Instead of being frustrated at "stupid drivers", I read an interesting article by Ben Wood in the Honolulu Star Bulletin (Saturday Dec. 13, 2008 edition): *Obama naming Shinseki veterans' chief was right.*

'A line Jack Lord would use when I had regular interviews with him in the old days was, "Good will out." That line works well in the case of former Army Chief of Staff Gen. Eric Shinseki of Kauai...'

This statement angered then Defense Secretary, Donald Rumsfeld, and resulted in General Shinseki's retirement.


