
- There were 18 member representatives, 1 guest and 2 no shows at the June 9th membership meeting held at the Moana Surfrider Hotel a Westin Resort.

Dinner consisted of a savory assortment of heavy "pupus," while lively conversations filled the room.

After dinner, Maegan Brandt introduced our guest speaker Derek Kurisu, Executive VP at KTA Super Stores and creator of Mountain Apple Brand. A successful businessman and community leader, Mr. Kurisu has been employed at KTA Super Stores for more than 38 years. Mr. Kurisu has been described as a homegrown ambassador for Hawaii. He says his goals are to make the Big Island and the State of Hawaii the greatest place on Earth and to have Hawaii products available throughout the world. He is also a media star who has two television programs on local cable called Seniors Living in Paradise and Living in Paradise. He also is a popular motivational speaker, doing about 50 engagements a year

Whether it's thousands at an exhibition or an intimate room full of EWI women, Mr. Kurisu feels comfortable speaking in front of his audiences. The wild, unpredictable comments, his life's lessons shared all are filled with humor and expressiveness. You never know what he's going to do or say. But you can never forget his messages.

Messages shared:

"If you're living in the islands, you gotta know customer service."

"I sit in front of KTA for hours, observing customers, their facial expressions and behavior. I realize customers look for more than service, price, variety and cleanliness in our store." They're mainly interested in, "What am I going to eat tonight? What am I going to bring to the party? What am I going to cook for my son's excursion tomorrow?" he recites.

"The purpose of being in business is to solve people's problems. If we can't solve their problems, they won't come back," he says.

This preoccupation with customer needs is a major sacrifice, Kurisu admits.

Customer service must be an organization's top priority and strength, Kurisu says seriously.

"When people work as a team in the area of strengths, it becomes one big awesome, unbeatable and unstoppable organization."

That's the way it is at KTA Super Stores, home of 750 employees, business partners, and associates.

Greatest Business Accomplishment: The creation of Mountain Apple Brand products. It is a private label that currently has over 285 items and 80 business partnerships.

Product shared that evening was a papaya-guava nectar called PAVA. Kurisu is involved in guiding this locally made juice to market. It was developed by students of his alma mater, University of Hawaii College of Tropical Agriculture. The enterprising students made use of discarded off-grade papaya and guava not sold in stores. "It's based on the plantation principle of turning waste into something of value," Kurisu says. "A little imagination is helping agriculture."

Philanthropy School Supply Drive Update.....

The school supplies collected by EWI were delivered to Bridget Kanakaole at Princess Victoria Kaiulani Elementary School in Kalihi. In total, there were 14 boxes of supplies! Because many of the students are from low-income families, Bridget said the supplies were very much appreciated and would be used by the children in the school in the classrooms. The students will not be allowed to take them home.

Princess Victoria Kaiulani Elementary School has also recently been adopted by a Rotary Club, which has developed a program with Hawaii Foodbank to pack and distribute bags of food each week for their students to take home.

Through your generosity we have achieved much for these children......As Walt Disney said, "many hands, hearts, and minds generally contribute to notable achievements."
